#### **MEMORANDUM**

**Subject:** Circular to Students on Institute of Chartered Accountants Of Zimbabwe (ICAZ)

Professional Programs Provider (PPP) Registrations.

#### Dear Students,

This memo is to inform you that all students intending to write the Assessment of Professional Competence (APC) will be required to meet the following prerequisites:

### 1. A valid professional programme certificate:

A professional programme certificate is valid for 3 years and is granted to students who are registered with the Institute of Chartered Accountants of Zimbabwe (ICAZ) upon enrollment with an accredited professional programme provider.

\* NB - Certificates issued for refresher courses are not considered valid unless the student was registered with ICAZ while undertaking the course.

## 2. A registered training contract with an ICAZ-approved training provider:

Students must have a registered training contract with an ICAZ-approved training provider with the exception for CIMA students. CIMA students are expected to be full CIMA members in good standing.

### Obtaining a valid professional programme certificate


To obtain a valid professional programme certificate a student is required to register with an ICAZ PPP and with ICAZ. Once registered a student is expected to settle the PPP applicable fees and an ICAZ fee of USD 250. On successful completion of the course, a student will be granted a professional programme certificate. Students with valid certificates are not required to submit the ICAZ registration and payment <u>unless</u> they intend to use the PPP certificate to be admitted in a future APC exam from 2025 onwards.
